ELDER LAW NEWS AND HIGHLIGHTS

MN NAELA Looking for Witnesses to Testify at Legislature to Support Repeal of Minn. Stat. 501C.1206

The Elder Law Section is now officially in support of repeal of Minn. Stat. 501C.1206. The Minnesota Chapter of NAELA is looking for Elder Law Section clients who would fall into the following categories and would be willing to testify at the Minnesota Legislature in support of repeal of Minn. Stat. 501C.1206:

- · A farmer whose main asset is a farm who would like to put the farm in an irrevocable trust to allow it to transfer to the farmer's descendants to keep the farm in the family and free of liability for long-term care expenses.
- · A client whose main asset is a single asset such as a retirement account, bank account, home, or business, who would like to put the asset into an irrevocable trust to allow the asset to pass to the client's descendants free of liability for long-term care expenses.
- · A client who was forced to pay for long-term care because the client placed assets into an irrevocable trust that was treated as revocable under Minn. Stat. 501C.1206 or its predecessor Minn. Stat. 501B.895.
