# MSBA and Elder Law Section Prepare for 2018 Legislative Session:

The 2018 Legislature is scheduled to begin at noon, Feb. 20, 2018. The Session must adjourn by May 21, 2018. Between those two dates the Legislature will consider a bonding bill, supplemental appropriations (or cuts) to balance the budget for the second year of the biennium, tax legislation to conform to recent federal changes, and numerous other bills that could affect the citizens of this State. The MSBA employs paid staff and a lobbyist to monitor activities at the Legislature each session that might be of special interest to attorneys. Each MSBA Section has a Legislative Committee and a Legislative Coordinator.

Since 1992 Julian J. Zweber has been chair of the Elder Law Section's Legislative Committee and has served as the Section's Legislative Coordinator. The MSBA has a Legislative Committee to supervise MSBA legislative activities. The MSBA Legislative Committee prepares the MSBA Legislative Agenda for each session, and monitors legislative activities that might be of interest to MSBA members. The MSBA Legislative Agenda for 2018 is available at <a href="http://www.mnbar.org/">http://www.mnbar.org/</a>. Log in and then go to "Public," then to "Government Relations" and then to "MSBA Legislative Positions." The MSBA Legislative Committee and its lobbyist keep Section Legislative Coordinators informed regarding introduction of bills and other developments of interest to attorneys at the Legislature.

The Elder Law Section's Legislative Committee and Section's Legislative Coordinator monitor proposed legislation at both the state and federal level affecting the Section's membership; review legislative proposals put forward by other MSBA Sections and Committees; review proposals from other groups, agencies and individuals; keep Section members informed of proposed legislation; provide comment and other responses to legislative proposals; make recommendations concerning support of, or opposition to, legislative proposals; develop relationships with other organizations affected by legislation of interest to the Section; act as a coordinator for the Section's legislative activities; develop legislative proposals for inclusion in the MSBA legislative agenda; provide witnesses and testimony in support of, or opposition to, legislative proposals; and in general support the MSBA and the Section's legislative agendas.

Now is the time to join the Elder Law Section's Legislative Committee if you aren't a member already and you have an interest in following elder law issues at the 2018 Legislative. Members of the Legislative Committee receive information by e-mail to keep them informed of proposals of special interest to the elderly. There are no meetings to attend during session because events move too quickly at the Legislature to accommodate meetings to develop section responses. Responses must come from individual committee members contacting their local

The Minnesota Consumer Work Group (made up of members of AARP Minnesota, Alzheimer's Association, Minnesota Elder Justice Center, Elder Voice Family Advocates, and Mid-Minnesota Legal Aid) released its report on January 29, 2018. # QUESTIONS AND ANSWERS FROM THE MSBA COMMUNITIES

- Q. Mom deeded homestead to son 14 years ago, reserving a life estate. Mom is 75 years old. Son is 45 years old. Both in good health, live at the homestead, and likely will for the foreseeable future. Son gets social security, including some amount of SSI, and is on medical assistance. I do not know the amount of SSDI, and the amount of SSI. The house is worth about \$60,000, If something happened to mom, son could not stay in the home, paying insurance, taxes, utilities, etc. Mom helps him now pay those. For the son, I see options such as:
- 1. Son could transfer the remainder interest to his three siblings. As the son is under 55 years of age, that should not affect medical assistance. However, he may be subject to a 36-month penalty for the SSI benefit he gets. Maybe the siblings could provide him with payment of some expenses he now pays to make up the loss.
- 2. Son could sell his life estate and use the monies for prepaid funeral, perhaps better vehicle, household furniture. Could also set up special needs trust, but may not be wise for only \$25,000 as a round number.
- <u>A.</u> Son cannot transfer his remainder interest for less than fair value without taking a penalty which would disqualify him for MA home- and community-based services in a roughly equal amount. There is no age limit on penalizing uncompensated transfers. Estate recovery is limited to services rendered in the home setting from age 55 onward; MA eligibility is not. Option No. 2

could be an option if otherwise advisable. Option No. 1 is not, unless the family pays for care during the resulting penalty period.
