Diversity and Inclusion

The following summarize the accomplishments of the Elder Law Section in the areas of Diversity and Inclusion:

- Helped plan and implement a successful National HealthCare Decisions Day in collaboration with Minnesota Elder Justice Center (MNEJC), Pro Bono and Law Students Committee.
- 2. Sponsored MSBA Convention for the Section, as this year's theme is Diversity.
- 3. Facilitated a partnership between MNEJC and Collaborative Community Law Initiative (CCLI) to help foster an influx of new lawyers to elder law with more diverse cultural and socio-economic backgrounds. Stay tuned.
- 4. Elimination of Bias CLE provided in December 2018; scholarship information sent out for ELI 2019; 4 diversity events advertised to Section members.

Other Section Accomplishments

Other notable accomplishments include the following:

Communications Committee:

- 1. 2018-2019 Year. The communications committee met bi-monthly in the past year.
- 2. <u>Newsletter.</u> Mardell Presler served as the editor of the newsletter. The format of the newsletter was refined to be more efficient for readers, and also included addition of photos. The newsletter continues to go out on a monthly basis.
- 3. Website Updates: Bridget has worked extensively on updating the MSBA website specifically in moving the content over to the "Communities" and encouraging other committees to do so as well. In the process of moving content, structures and layouts were reassessed to promote efficiency and ease of use for members. We saw implementation of this in the past year, and are currently working encourage increased participation in the online communities from all committees and elder law section members.

Legislative Committee:

1. Section Only Position. Beginning in August 2018, the Legislative Committee sought to collaborate with the Health Law Section in a joint position in support of licensing assisted living facilities and increasing dementia care standards. After discussion, the Health Law Section determined that although they did not oppose the position, they declined to join in such a position due primarily to lack of knowledge. Therefore, for the first time in recent history, the Elder Law Section approved the following "section only" position on 10/23/2018 and submitted the same to MSBA leadership on:

Resolved that the Elder Law Section supports the creation of an assisted living license that replaces housing with services registration for those entities choosing to operate as an assisted living establishment and the creation of a dementia care unit certification for those providers offering dementia care, for the purposes of providing greater protection and clarity for consumers and providers as well as balanced administrative oversight based on level of assessed need.

No other section of the MSBA opposed the position and the MSBA President agreed to allow the Elder Law Section's proposal to proceed as a section-only position. The section-only position was communicated to the Minnesota Department of Health and stakeholders in support of proposed legislation for an assisted living license and dementia care certification. Such legislation was proposed in both the 2018 and 2019 legislative sessions.

2. 2019 Legislative Session. Building off of last legislative session, many stakeholders met over the course of the summer, fall, and during the 2019 session, facilitated by the Minnesota Department of Health. HF90/SF8 were introduced with many similar provisions to those

introduced last legislative session. The bill passed and was signed by the Governor on 5/22/2019.

The following are key provisions in the bill:

- Creates Assisted Living Licensure & expand dementia standards
 - o Separates AL into two licenses
 - AL facility AL defined as providing sleeping accommodations and AL services
 - AL facility with dementia care Secured AL dementia care units must be licensed as AL with dementia care
 - o Single contract for housing and services
 - o Corporate disclosure requirements and definitions of controlling individuals
 - o Restriction of transfers of ownership
 - o Establishes minimum services
 - o Establishes minimum policies and procedures
 - o Requires nursing assessment upon admission
 - o Creates an appeal process for AL discharge
 - o MDH charged with rule making beginning 7/1/2019
 - o Effective 8/1/2021
- Expands former Board of Nursing Home Examiners to Board of Executives for Long Term Services and Supports to oversee Directors for Assisted Living
 - Effective 7/1/2020
- Expands retaliation prohibition provisions
 - o In AL, nursing home, and HWS settings
 - o Presumption of retaliation for certain actions within 30 days of complaint
 - Effective 8/1/2019
- Create process to appeal assisted living discharge
 - o Termination of services or non-renewal of housing
 - Create a relocation plan
 - o Right to return to facility if absent
 - o Effective 8/1/2021
- Allow placement of a camera in assisted living and nursing home
 - o Guardian, health care agent, and person designated in writing can place camera
 - o Notice to facility required by use of form
 - o 14-day exception to notice under certain circumstances with notice to Ombudsman
 - Effective 1/1/2020
- "I'm Okay" checks must be in writing in unlicensed settings
 - o Effective 8/1/2021
- Establishes a 2-year maltreatment compensation fund; client can accept \$5,000 in lieu of civil action
 - o Seen as a temporary protection until AL licensure
 - o Effective 7/1/2019
- Assisted Living resident survey funds set aside and intent to develop AL report card

- Establishes additional funds for the Ombudsman for Long Term Care (17 new positions)
 - o \$1,456,000 in FY2020 and \$2,023,000 in FY2021
- Establishes resident and family surveys of HWS
 - o \$2,682,000 in FY2020 and \$2,702,000 in FY 2021
- Additional funding
 - o \$7,438,000 in FY2020 and \$4302,000 in FY2021 for MDH regulatory improvements
 - o \$2,218,000 in FY2020 and \$5,114,000 in FY2021 to establish AL license

The following are provisions that, although proposed, are not included in the bill:

- No private right of action for violation of bills of rights
- No prohibition against deceptive marketing
- No general damages for vulnerable adults who are injured and die of unrelated causes (Minn. Stat. § 573.02, subd. 2)
- No staffing levels
- No increase in AL fines for regulatory violations
- No discharge and appeal rights from assisted living for 2 years
- 3. Other Legislative Impacts and Future Initiatives.
 - Elderly Waiver recodification accomplished 2019
 - Tax bill provisions approved in 2019 (from MSBA)
 - o Attributing a deceased spouse's ownership to a surviving spouse for purposes of the three-year holding requirement in the qualified farm and small business estate tax exemption (Article 2, Sections 23, 24).
 - o Allowing married farm couples who hold their property in two linked trusts to maintain agriculture homestead status (Article 4, Section 12).
 - o Removing the six-year timeline for an innocent spouse to request separation of tax liability (Article 2, Section 9).
 - o Enabling state relief for taxpayers who qualify for "equitable" innocent spouse relief under federal law (Article 2, Section 9).
 - Opioid legislation has impact on vulnerable adults
 - Authority to temporarily freeze accounts proposed to be expanded, to combat financial exploitation
 - Vulnerable Adult Act updates sought in the future (outside consultant hired)
 - Value Based Reimbursement System for nursing home Medicare/Medicaid reimbursement
- 4. *Statutory Short Form Power of Attorney*. Statutory Short Form Power of Attorney committee received additional feedback from the Uniform Law Commissioners. The committee will continue its work to respond to the feedback and hopes to bring a draft proposal in the 2020-2021 legislative session.
