<p><b>Public Attorney</b> - A member employed exclusively by a government agency full or part-time.</p> <p><b>Legal Services</b> - A member employed by a legal services program representing low-income clients for no charge or a reduced fee.</p> <p><b>Nonresident</b> - A member admitted to the Minnesota bar who neither resides nor practices law in Minnesota.</p> <p><b>Under \$45,000 Income</b> - A member with adjusted gross income from all sources, excluding the income of a spouse, of less than \$45,000 for the past year.</p> <p><b>Emeritus</b> – A member 70 years or older, no longer in full-time practice.</p> <p><b>Retired</b> – A member who has been granted <u>retired status</u> on his or her license by the Supreme Court.</p> <p><b>Disabled</b> - A member who is totally disabled is exempt from state and district dues.</p> <p><b>Active Military</b> - A member on <b>active</b> duty (other than for training) with the United States armed services, Peace Corps, or VISTA.</p>
