Scrimmages will be arranged between teams who are not scheduled to meet each other in Rounds 1, 2, 3 or 4 of the State Bar's regional competitions, although our ability to do that will be determined by the teams that register.

First Round: 9:00 AM

Second Round: 11:45 AM

*Recognition will be given to Teams with best total performances!*

Fee: \$145.00 per team to cover expenses for ten team members + lunch.

The first 24 teams registering (with payment received) will be accepted. In the event of an uneven number, we will attempt to put together a "bye" team. Schools will be notified if this occurs. Each school needs to provide at least one attorney/coach to judge scrimmages. (*If you bring two teams, you must provide at least two attorney/coaches to judge other teams.*)

Dear Mock Trial Colleague,

You are invited to participate in Apollo's 25<sup>th</sup> Annual Mock Trial Invitational. We hope you will consider joining us on Saturday, January 5<sup>th</sup>, 2019 for this event.

As noted on the included "poster" announcement, scrimmages will be scheduled between teams who are not scheduled to meet each other in Rounds 1, 2, 3, or 4 of the State Bar's regional competitions based on information from the Minnesota State Bar. However, our ability to do that will be determined by the teams that register.

The **First Round** is scheduled for 9:00 AM, and the **Second Round** for 11:45 AM. *Recognition will be given to teams with best total performances!*

Fee: \$145.00 per team to cover expenses including lunch for ten team members. If there are more than 10 members, lunch can be purchased for \$7 on day of Invitational. The first 24 teams registering (with payment received) will be accepted. Each team needs to provide at least one attorney/coach to judge scrimmages. (*If you bring two teams, you **must** provide two attorney/coaches to judge another team during each round.*) The registration form is reproduced below. (Please write the name: 'Jane Keenan' on the envelope when you mail your registration – so that it arrives quickly in the right place.) Confirmations will be sent by e-mail.

We will again be providing *Mexican Village* hard & soft-shell tacos, and taco salads for lunch (vegetarian option available). Water will be provided. Please note on the registration the number of vegetarian meals for team.
