## Special Master (\$2,500)

## Venireman (\$600)

Your \$600 funds a 1-day dissolution clinic allowing 6 low income clients to obtain a divorce through SMRLS, or covers 6 months of representation for one child plus attendance of an attorney at emergency protective care hearings for 2 children through Children's Law Center.

## Bailiff (\$400)

For a donation of \$400 you will receive:

- ✓ Two tickets
- ✓ Event Recognition:
  - Signage placed prominently at event registration tables
  - Acknowledgment in event program

Your \$400 funds a SMRLS 1-day criminal or eviction expungement clinic for 5 clients to obtain court approval to clear their record and become employed and/or end homelessness, or covers a full day of court hearings, representing up to 36 cases and attendance of an attorney at emergency protective care hearings for 3 children through Children's Law Center.
